### Management Liability Insurance Specialist (MLIS™) Scholarship Description, Who Benefits, and How

The MLIS certification and continuing education (CE) program was developed by IRMI and is delivered by WebCE via state-of-the-art online technology. The program is designed to make it much easier for CSRs, account managers, insurance agents, and brokers to gain specialized expertise in the fundamentals of professional liability insurance and the more specific nuances of directors and officers liability, employment practices liability, and fiduciary liability exposures and insurance. These specialized lines of insurance are often called “management liability” or “executive liability,” hence the name of the program. Obtaining the MLIS certification will increase the competence, confidence, and credibility of insurance professionals who sell and service these lines of insurance. An insurance buyer or risk manager who buys insurance or seeks advice from an MLIS designee will know he or she is dealing with someone who is committed to staying abreast of this complex and constantly changing insurance specialty.

All MLIS courses have been filed for state-required insurance CE credit in all 50 states. The scholarship includes all of the courses below (worth \$500); however, if you desire CE credit, a \$15 fee per course applies and is not included in the scholarship.
